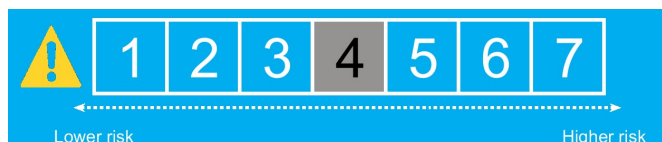

## What is this product?

<b>Type</b>	The product is an open-ended Irish Collective Asset-management Vehicle (ICAV) Fund with segregated liability between Sub-Funds authorised as an undertaking for collective investment in transferable securities (UCITS).
<b>Term</b>	This product has no maturity date. However, the Board of Directors may decide to close the product under certain circumstances.
<b>Objectives</b>	<p>The investment objective of the Sub-Fund is to provide attractive risk adjusted returns from a combination of investments in equity and debt instruments as well as authorised collective investment schemes. The Sub-Fund will have a focus on developed capital markets. There can be no assurance that the Sub-Fund will achieve its investment objective. The Sub-Fund will seek to achieve its investment objective by investing directly in:</p> <ul style="list-style-type: none"> <li>• A broad and globally diversified range of asset types which will consist of equities, debt securities and collective investment schemes.</li> <li>• The equities the Sub-Fund holds will consist of shares issued by a range of companies operating in different geographical regions and business sector. The companies will vary in terms of size.</li> <li>• The debt securities in which the Sub-Fund invests may include fixed and floating rate corporate and government bonds, notes and debentures. The rating of these may be investment grade or high yield or unrated.</li> <li>• Such instruments shall not exceed 90% of the Net Asset Value of the Sub-Fund.</li> <li>• The exposure obtained through investments in collective investment schemes will be consistent with the overall investment strategy of the Sub-Fund.</li> <li>• The Sub-Fund may invest up to 20% of its Net Asset Value in collective investment schemes.</li> <li>• The Investment Manager invests in a diversified portfolio and has the flexibility to change the allocation between sectors and asset classes where these are consistent with the Sub-Fund's investment policy.</li> <li>• The Sub-Fund may hold up to 50% of the NAV of the Sub-Fund in cash and including, for the avoidance of doubt, Money Market Instruments.</li> <li>• The Sub-Fund is actively managed without reference to any benchmark.</li> </ul> <p>The Sub-Fund launched on 03 July 2017. <b>Intended Investor</b>	The Sub-Fund is suitable for Retail Investors. A typical investor in the Sub-Fund may be an investor with a high-risk tolerance and with an investment horizon of 5 years or longer who considers investment in the Sub-Fund as a convenient way of seeking to generate attractive risk adjusted returns through an exposure to global equities, debt instruments and collective investment schemes.

## What are the risks and what could you get in return?



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

**Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.**

Investors shall note that besides the risks included in the risk indicator, other risks such as liquidity, counterparty, currency, credit risk, fixed interest securities risk and equity investment risk may affect the Sub-Fund's performance.

This product does not include any protection from future market performance so you could lose some or all of your investment.

## Performance Scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

## What happens if FundRock Management Company S.A. is unable to pay out?

The Management Company is responsible for administration and management of the Sub-Fund, and does not typically hold assets of the Sub-Fund (assets that can be held by a depositary are, in line with applicable regulations, held with a depositary in its custody network). The Management Company, as the PRIIPs manufacturer has no obligation to pay out since the product design does not contemplate any such payment being made. However, investors may suffer loss if the Sub-Fund or the depositary is unable to pay out. There is no compensation or guarantee scheme in place which may offset, all or any, of this loss.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Table 1: Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product, and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

## How long should I hold it and can I take my money out early?

### Recommended holding period: 5 years

You should be prepared to stay invested for 5 years. However, you can redeem your investment, the Sub-Fund may accept requests for redemptions on each Business Day at a price equal to the Net Asset Value per Share of the relevant Sub-Fund. Minimum redemption is a £1000 or such other amount as the Directors may in their absolute discretion determine and Redemption requests for amounts less than the minimum redemption will be refused.
